I hereby request that you issue a warrant to search the premises listed below.

This request is made in conjunction with the criminal investigation of:

1. Karl Bassler, Odenwaldweg 4, 71032 Böblingen
2. The Officers of the Böblingen Circle for Culture and History.

The investigation is made on the charge of Incitement of the People:

As stated in §33 para. 4 German Penal Code, without prior hearing;  
on grounds of §§94, 95, 98, 99, 100, 102, 103, 105, 111b, c ff., 162 German Criminal Code  
of Procedures

The premises to be searched are:

1. The residence and attached rooms of Karl Bassler, Odenwaldweg 4, 71032 Böblingen;
2. The rooms of the "Böblingen Circle for Culture and History;"
3. Post Office Box 1113, 71094 Schönaich

The items to be seized are:

1. Written documents revealing information about publications on the Internet, in particular information concerning members of the "Committee for Open Debate on the Holocaust" who are in contact with Germar Scheerer; as well as further criminally relevant, documents inciting the masses, in particular documents of an anti-Semitic nature; as well as all objects used for criminal purposes such as computers, computer accessories, storage media, etc.
2. All letters and other mail addressed to the accused Bassler, the responsible member of the Circle for Culture and History Böblingen, as well as Germar Scheerer at Post Office Box 113, 71094 Schönaich  
The opening and inspection of letters and mail is delegated to the Office of the Public Prosecutor of Stuttgart (§ 100 para. 3 German Penal Code)

Reasons for This Search:

Material inciting the masses is currently being distributed, or mailing addresses are being listed, at the Internet web site "<http://www.codoh.com>".

The above address is given as a contact address for the convicted and absconded Germar Scheerer.

It is suspected that contraband written material such as the Rudolf Expert Report, "Auschwitz: Nackte Fakten" (Auschwitz: Plain Facts) and "Grundlagen zur Zeitgeschichte" (Foundations for Contemporary History / Dissecting the Holocaust), are distributed by the accused persons mentioned above and at their addresses. (§130 para 2 no. 1 German Penal Code)

It is expected that the search will lead to the evidence described above.  
The tools of the crime are to be confiscated.
